WAIVER FORM

380 ROTARY CLUB EVENT WAIVER FORM

WAIVER OF DAMAGES THAT MAY ARISE FROM ACCIDENT OR INJURY DURING PARTICIPATION IN THE UNION PARK CHRISTMAS PARADE

1. **AUTHORITY:** I warrant and represent to the 380 Rotary Club Event Committee (the "Parade Sponsors"), that I have the authority to bind the association and/or organization and its members (the "Entrant"), with regards to our entry and participation in the 2019 Union Park Christmas Parade (the "Parade"). On behalf of the Entrant, I agree that our entry and all persons associated with it shall comply with all rules prescribed by the Parade Sponsors as deemed necessary for the efficient and safe conduct of the parade and all related activities. I agree to conduct our entry and myself in a proper, appropriate manner during the event and related activities and not to engage in any activity that is dangerous or likely to cause harm, injury or damage to the person or property of others.

2. **INDEMNIFICATION/RELEASE:** IN CONSIDERATION OF RECEIVING PERMISSION FROM THE PARADE SPONSORS TO PARTICIPATE IN THE PARADE, THE RECEIPT AND SUFFICIENCY OF WHICH IS HEREBY ACKNOWLEDGED, THE UNDERSIGNED FOR THE ASSOCIATION AND/OR ORGANIZATION AND ITS MEMBERS, OFFICIALS, OFFICERS, EMPLOYEES, AGENTS, VOLUNTEERS, HEIRS, DISTRIBUTEES, NEXT OF KIN, DEPENDENTS, PERSONAL REPRESENTATIVES, EXECUTORS, ADMINISTRATORS, SUCCESSORS AND ASSIGNS, AND ALL OTHER RELATED PERSONS OR ENTITIES (HEREINAFTER COLLECTIVELY REFERRED TO AS "RELEASORS"), DOES HEREBY AND SHALL TO THE FULLEST EXTENT PERMITTED BY LAW WAIVE, RELEASE, INDEMNIFY, DEFEND AND HOLD HARMLESS THE 380 ROTARY CLUB AND EVENT COMMITTEE, THE UNION PARK CHRISTMAS PARADE EVENT COMMITTEE, THEIR OFFICIALS, OFFICERS, EMPLOYEES, AGENTS, VOLUNTEERS AND ASSIGNS, HILLWOOD DEVELOPMENT COMPANY, LLC AND ITS OWNERS, AFFILIATES, EMPLOYEES, OFFICERS, DIRECTORS, REPRESENTATIVES, SUCCESSORS, ASSIGNS, SPONSORS AND VOLUNTEERS, THE UNION PARK RESIDENTIAL COMMUNITY ASSOCIATION, INC, THE HIGHWAY 380 MUNICIPAL MANAGEMENT DISTRICT NO. 1 AND ALL OTHER RELATED

PERSONS OR ENTITIES, (HEREINAFTER COLLECTIVELY REFERRED TO AS “RELEASEES”) FROM AND AGAINST ANY AND ALL CLAIMS, SUITS, JUDGMENTS, COSTS, ATTORNEY’S FEES, DAMAGES OR OTHER LIABILITY OR RELIEF WHATSOEVER, ARISING OUT OF OR RELATED TO ANY LOSS, DAMAGE OR INJURY, INCLUDING DEATH, THAT MAY BE SUSTAINED BY THE UNDERSIGNED AND/OR ANY PROPERTY OF THE UNDERSIGNED, AND/OR THE RELEASORS, DURING AND/OR RELATED TO PARADE PARTICIPATION. IN THE EVENT OF ANY ACTION OR PROCEEDING AGAINST THE RELEASEES, COVERED BY THE FOREGOING WAIVER AND/OR DUTY TO INDEMNIFY, DEFEND AND HOLD HARMLESS, SUCH ACTION OR PROCEEDING SHALL BE DEFENDED BY LEGAL COUNSEL OF 380 ROTARY CLUB’S CHOOSING AND THE COST THEREOF SHALL BE PAID BY THE UNDERSIGNED ASSOCIATION AND/OR ORGANIZATION.

In the event the Entrant is to operate a motor vehicle in the Parade, it represents and warrants to the Parade Sponsors that the operator of any such motor vehicle shall be a licensed driver and it shall provide to the Parade Sponsors concurrently with the submittal of this executed form proof of comprehensive automobile liability insurance covering the motor vehicle to be used in connection with the parade. The Entrant represents and warrants that it shall keep such automobile liability insurance in effect through and including the date of the Parade. **THE ENTRANT BEING DULY AWARE OF THE RISKS AND HAZARDS INHERENT IN PARADE PARTICIPATION, THE ENTRANT HEREBY VOLUNTARILY ASSUMES ALL RISKS OF LOSS, DAMAGE, OR INJURY, INCLUDING DEATH, THAT MAY BE SUSTAINED BY THEM.** The Entrant hereby declares and represents that no promise, inducement or agreement not herein expressed has been made to them and that the terms of this waiver and release are contractual and not merely recital. This waiver, indemnity, release and assumption of risk shall survive the Parade. The Entrant hereby acknowledges and represents that the person signing this waiver and release and assumption of risk for the Entrant is eighteen (18) years of age or older and of sound mind and in authority to bind the Entrant.

3. ACKNOWLEDGEMENT OF RESPONSIBILITY AND RISK: I, _____ (name of Participant/Sponsor) do voluntarily agree to participate in the Parade and the undersigned acknowledges that there may be some hazard of personal accident or injury during the participation of said event and willingly accepts responsibility for any personal injury that may arise from this voluntary participation. I further acknowledge that participation in the Parade is a challenge and engages the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of injury. Understandably, not all hazards and dangers can be foreseen. The very nature of participation in the Parade can have risks, including, but not limited to, overexertion, slips and falls, lack of good physical conditioning, inadequate or defective equipment, inadequate instruction or supervision, poor technique, carelessness, horseplay, and all other risks inherent in the parade participation. In this regard, it must be recognized that it is impossible for the Parade Sponsors to guarantee absolute safety.

I HEREBY WARRANT AND REPRESENT THAT I HAVE READ AND UNDERSTAND THE ABOVE BEFORE SIGNING AND THAT I AM DULY AUTHORIZED TO BIND THE BELOW PARTICIPANT AND ITS MEMBERS TO SUCH REPRESENTATIONS. I FURTHER ACKNOWLEDGE THAT THIS DOCUMENT IS A WAIVER OF RIGHTS AND AN ACCEPTANCE OF RESPONSIBILITY.
